The Motor Carrier Division (MCD), Oversize/Overweight (OS/OW) Permits Office is required to have weights verified on loads that exceed 500,000 pounds. The Texas Department of Motor Vehicles (TxDMV) reserves the right to require verification of weights on any load the Department deem necessary.

In order for the Super Heavy Permit to be processed, the weight must be certified by a weighing agent. The weight of the gauge reading must be certified by one of the following:

- License and weight inspector of the Texas Department of Public Safety,
- A highway patrol officer,
- A sheriff or sheriff's deputy,
- A municipal police officer,
- A police officer certified under Texas Transportation Code §644.101,
- A constable of deputy constable designated under Texas Transportation Code, §621.4015, or
- Any Texas Department of Transportation (TxDOT) or TxDMV personnel that is identified and approved by the MCD OS/OW Permits Office.
